

Australia's Digital ID System – Submission

October 2, 2023.

I am writing to object to *every little thing* that is proposed in the name of establishing an Australian Digital ID system.

Unfortunately, I only heard of this submission opportunity and cut-off date this week, so I have not done a deep dive into the corruption level of this proposal.

However, do not interpret that comment as an admission of me having no idea... quite the contrary, I have worked for many years in the sorts of places and professions that allow me to know exactly what is going on here...

And by the way – Digital ID was a conspiracy theory – right?

My objections to the Digital ID system:

1. Who said we want to be numbered and digitized? Under who's authority are you taking these measures to give each person a Digital ID? Certainly not the approval of Australian men and women. We do not approve.
2. Already there are laws and regulations in Australia to ostracize and outlaw anyone who does not conform to certain procedures on the basis of licences, tax file numbers, banking account regulations, medical status, etc.
3. Digital ID is part of an international identification system, we know that. Already our ID systems are set up to be compliant with ISO standards – such as the Directors' ID. A quick visit to the ISO website and search for the *World Economic Forum* (WEF) will show over 200 articles in the ISO website that outline the guidelines/directives of the WEF in relation to International Standards.
4. What are all the surveillance cameras being put up all over the place? Exactly what has facial recognition got to do with our safety and security? There is no way that 100 “security cameras” in major shopping centres, such as Woolworths and Coles (to name a few) have anything to do with our safety and security. It is about surveillance and control, using Digital ID in the future. We did not give our consent to this.
5. The Reserve Bank of Australia website clearly shows evidence of pilot programs for Central Bank Digital Currency (CBDC) already having been completed. For well over 18 months, or more. Combined with the Bank of International Settlements stating that they want to be able to track and trace EVERY financial transaction made, we certainly have many reasons to be concerned over our safety, protection, freedom, and humanity.

Physical cash/notes are fast losing their status as legal tender. Where was this approved, and by whom?

6. Please demonstrate clearly, *and under oath*, that the Australian Digital ID system is not EVER going to be linked up with international ID systems, such as travel passports. Oh, woops, I don't think that would pass the test already.
7. Please demonstrate clearly, *and under oath*, that the Australian Digital ID system has nothing to do with ANY international bodies, all unelected – such as the World Health Organization (WHO), One Health, the United Nations, the World Economic Forum, World Health Assembly, ASEAN, and ALL OTHER international bodies, foundations, organizations, charities, international alliances, etc.

8. Please explain why there has been such a drive to go well beyond the present global barcoding system for goods, to now forcibly impose a digital ID on *every living thing* – or should I say “asset”? This includes all cattle, which already have digital IDs, the recent attempted introduction of eID for all sheep in Australia, etc. And now Australian men and women.
9. How does the Digital ID link in with international and national surveillance systems? Give exact details, under oath, on the Digital IDs “compatibility” with communication tower signals, Smart City (with the numerous and various other names) tracking and tracing, 2FA, satellite surveillance and monitoring, Smart appliances, digital and other phones, QR coding systems, etc?

Exactly how does our Digital ID differ from the one already introduced in such countries as China, which now restricts the behaviour and amenities to people who do not follow the national manipulative directives? What guarantees can you make, under oath, that our digital ID system will NEVER be linked to any freedom restrictions. (Well, already that is impossible, because here I am, on a national holiday, typing out a submission to ensure that I retain my freedom. The irony is not lost on me.)

How does this new, proposed, Digital ID interlink with Australia’s MYGOVID and all the other IDs we already have – that CENTRALIZE health, employment, disability, pensions, tax, employment etc etc. We disagree with centralization – we support individual liberty and freedom.

11. What exact proof can you show the men and women of Australia that this is not part of a criminal process to enslave us? The fact that the Australian Government continues to allow the rollout of harmful medical procedures, still, in October 2023 is proof that we are dealing with a criminal organization.
12. Please show any and all proof, under oath, that Australia is a sovereign nation.
13. All government employees working in the interest of unelected international entities are performing treasonous acts and are exposed to charges of malfeasance in public office – both are criminal offences.
14. Show proof that we have exited ALL international bodies that no longer support the health, freedom, autonomy, wealth, free thought and free expression.
